REGULAR MEETING

6:30 PM, VIRTUAL MEETING VIA ZOOM PLATFORM April 21, 2020 District Mission Statement

The board meeting was held remotely via the Zoom Platform. The link to access the meeting was placed on the district's website with directions on how to attend and participate. The information was also provided via a letter emailed to all the parents/guardians in the district. The directions on how to participate in the public portion were reviewed before the actual start of the meeting.

SUPERINTENDENT'S REPORT

- Enrollment Report- The March enrollment is in the board's folder.
- Our district is in the sixth week of instruction under the "Flexible Learning Plan", due to Governor Murphy's Executive Order that all NJ school buildings are closed. The latest directive from the Governor indicates that all school buildings will remain closed until at least May 15th. For now, until the next directive from the Governor, Lincoln Park Schools will continue with remote instruction. Mr. Grube stated that this is a very difficult and stressful time for staff, students and parents. We need to continue to work together and make the best of a terrible situation. Instruction is taking place, learning is taking place, and counseling is taking place. Lincoln Park Schools will continue to do great things, not just in the traditional manner. Mr. Grube stated at the last meeting as well as in his correspondence with the staff, students, and parents that he is extremely proud of the entire Lincoln Park community on how we are all pulling together to make this work. As he does not know what the directive from Governor Murphy is going to be, he does believe we need to be prepared for the very good chance the school buildings will not be open for the remainder of the school year, however, we will stay optimistic that we will return this year.
- President Avena asked if there are situations with students having struggles during these tough times. Mr.
 Grube responded that we are being flexible during remote learning. Trustee Nagle inquired on how students
 will be evaluated. Mr. Grube stated that students will be graded, report cards will need to come out and
 curriculum will be evaluated for the next school year.
- Mr. Grube reminded everyone of the new lunch distribution procedures. Lunches will now be distributed Monday and Wednesday from 10:30 to 12 noon at Lincoln Park Middle School. On Monday food will be given for Monday and Tuesday. On Wednesday food will be issued for Wednesday, Thursday and Friday. All Free & Reduced Lunch students are eligible as well as any student who would like to purchase a meal. If anyone is having difficulty getting lunches please contact our offices or your child's principal. Also this week the principals emailed all our students with information on how to apply for free or reduced lunches. Many of our families' financial situations have changed and may now be eligible. Mr. Grube encouraged all to complete the application and advised everyone that the application can also be found on our district website.
- Mr. Grube also wanted to remind everyone that the public presentation of the 2020-21 budget will be
 presented at the May 5th board meeting, and at the May 12th board meeting that the Board will officially
 approve the budget to be submitted to the State. Both of these meetings will be held remotely and
 information about the meetings will be available on the district website.
